

## Cooperation Agreement

THIS AGREEMENT is entered into by and between

**Berkman Center for Internet & Society**, Harvard University, 23 Everett Street, Cambridge, MA 02138, USA, represented by Prof. Urs Gasser

and

Korea University Legal Research Institute, represented by KIM Jewan  
on behalf of itself and the two of its sub-Centers: Internet Law Center (headed by LEE Daehee) and Cyber Law Center (headed by PARK No-hyung); and  
Korea University Clinical Legal Education Center, represented by CHUNG Young Hwan  
on behalf of itself and its Internet Law Clinic and Korea Internet Transparency Project (headed by K.S. PARK),  
all located in Anam-dong, Seoul, Korea, (collectively called “**Korea University Internet and Society Consortium**”), acting jointly and severally,

Agree as follows:

### (1) Aim

This agreement aims to create a network among the parties to facilitate cooperation.

### (2) Scope

The cooperation will focus on projects of mutual interest and require consent of the parties partaking on a case-by-case basis.

Such projects may include:

- participating in Global Network of Research Centers of Internet and Society as member research centers
- participating in Digital Asia Hub and taking leadership roles therein (e.g., Steering Committee either through institutional membership or by supporting personal participation of member faculties)
- joint research projects, including workshops, conferences, edited volumes and special journal editions, as well as joint research proposals;
- exchange of research scholars, so that scholar from one partner can conduct research at another partner's institution;
- joint executive education programs and similar short-term teaching initiatives.



The scope of the collaboration is not limited to the types of cooperation listed above, and with the consent of the parties may be extended to other areas.

Any party is free to refrain from cooperating on a particular project, which other parties may decide to pursue.

### **(3) Intensity**

- (a) The parties agree to aim at undertaking at least one (1) joint activity per year. At the beginning of each academic year according to Harvard University's academic calendar, the parties will define the envisioned activities and share it in a memorandum.
- (b) The parties commit to supporting participation of at least one (1) faculty-level member in a Digital Asia Hub event and an NOC event respectively per year.
- (c) Korea University Internet and Society Consortium agrees to aim at drawing sufficient input and support from Korea into the creation and governance of the Digital Asia Hub whereas Berkman Center agrees to aim at playing the role of the main global facilitator of the Digital Asia Hub.

### **(4) Cost**

The parties will team up to cover the costs of the collaboration. Until such funds have been secured, each party covers its own cost, including cost for research, administration, and travel (e.g., costs for sending fellows to partners and all resulting applicable fees). This collaboration agreement itself does not incur any annual fee.

### **(5) Persons in Charge**

The Berkman Center appoints as person in charge for this Agreement Prof. Urs Gasser. The Korea University Internet and Society Consortium appoints as point of contact for this Agreement Prof. K.S. Park. If a party wishes to change the point of contact, it shall inform - serving a one month notice - the other party, which may choose to terminate this agreement.

### **(6) Cross-Linkage**

The parties may disclose the existence of this cooperation to the general public, including on their websites.

### **(7) Duration**

This Agreement shall be for two (2) years from the signing below, and the parties hereto may extend the above period through mutual agreement. However, each party may terminate this agreement at any time serving the others a three months notice.



**(8) Additional Members**


Upon agreement by all parties, additional institutions may be invited to join this cooperation agreement.

**(9) Amendments**


This agreement can be amended upon agreement by all parties.


