### Student and Faculty Exchange Agreement between Korea University School of Law and The University of California at Davis, School of Law

#### Part One General

- 1. The parties to this Exchange Agreement are the Korea University Law School ("KU Law School") and the School of Law at the University of California at Davis ("UC Davis Law School").
- This Student and Faculty Exchange Agreement ("Exchange Agreement") is intended to provide opportunities for law students selected by UC Davis Law School to study for one semester at Korea University Law School and for law students enrolled at and selected by Korea University Law School to study law for one semester at UC Davis.
- 3. This exchange arrangement shall be based upon an exchange of an equal number of semesters spent by the exchanged student at each of the respective law schools in an academic year. It is anticipated that up to four Korea University Law School students will study during an academic year (two each single semester) at UC Davis Law School, and four Davis law students will study for a single semester at Korea University Law School. Provided that the exchange is equivalent over a five-year period, the number of semesters exchanged need not balance every academic year.
- 4. If the number of students to be exchanged in a five-year period is not equal, the parties shall consult and may agree on rectifying the imbalance by an appropriate increase or decrease the following year, or by any other arrangement mutually agreed upon. Both parties leave open the possibility that the numbers of students and/or semesters of exchange may be increased or decreased depending upon need, recognizing that any increase in the number of participating UC Davis law students may require approval by the American Bar Association.
- 5. Participating students will be selected by their home law school on the basis of the following criteria which shall generally apply but may be deviated from in appropriate cases (as determined by the home law school):
  - (a) Good academic standing, as reflected by grades in the top one-half of the class for all university law school work completed.

- (b) Appropriateness of the program of study to be undertaken through the exchange program.
- (c) Demonstration of appropriate language skills. (UC Davis 570 TOEFL or its equivalent)
- 6. Each of the participating law schools agrees to appoint a Liaison Officer who shall provide advisory and other academic services to students participating in the exchange under the terms of this Exchange Agreement.
- 7. Korea University and UC Davis law students participating in the exchange program shall pursue an academic program which is developed in consultation with their host law school and which conforms with the regulations of the host university, and will have the rights and privileges enjoyed by other students on the host campus. Students participating in the exchange program shall be subject to the rules, regulations, and discipline of the host law school. The two law schools will provide each other with information on the academic performance of the participants.
- 8. Each of the participating law schools agrees to waive tuition charges for their exchange students on a reciprocal basis.

# <u>Part Two — University of California Davis Law Students at</u> <u>Korea University Law School</u>

- 9. UC Davis law students selected to participate in the exchange program will have the option of studying at the Korea University Law School either in the Fall or the Spring semester, which dates approximate those of the Fall and Spring semesters at UC Davis Law School.
- 10. UC Davis law students will be permitted to enroll in those law courses designated by Korea University Law School as appropriate to students who have completed at least one year of graduate legal study.
- 11. UC Davis law students will earn no fewer than 10 and no more than 17 semester credits for the course of study at Korea University Faculty of Law provided such work is completed satisfactorily according to the academic standards of both law schools.
- 12. Korea University Law School will make every reasonable effort to assist UC Davis law students in locating housing. On-campus accommodation is available but not guaranteed. For UC Davis law students who wish to live off campus Korea

- University will provide a list of rental agencies. Payment for housing shall be the responsibility of UC Davis law students.
- 13. Korea University Law School will, in a timely manner, provide to UC Davis Law School a transcript for each UC Davis law student with grades for each course taken at Korea University Law School Law School.

## <u>Part Three — Korea University Law School Students at the</u> <u>University of California at Davis</u>

- 14. Students enrolled at and selected by the Korea University Law School to participate in the exchange program shall be given the opportunity to take a full course of study at UC Davis Law School during each semester.
- 15. Korea University Law School students will be permitted to enroll in any courses offered to UC Davis law students on a space available basis, provided that the course selection has been approved by UC Davis Law School.
- 16. Korea University Law School students will earn no fewer than 10 and no more than 17 UC Davis semester credits for their course of study at the UC Davis Law School provided such work is completed satisfactorily according to the academic standards of both law schools. Korea University Law School will determine the articulation of those units into its academic program according to Korea University academic policies.
- 17. UC Davis will assist the Korea University Law School students in locating housing (payment for housing shall be the responsibility of the Korea University Law School students). For those Korea University Law School students who wish to live on UC Davis campus, UC Davis will attempt to secure such housing in advance of the students' arrival. For those Korea University Law School students who wish to live off campus, UC Davis will provide the students with information on long and short-term rental opportunities and will assist them in locating housing.
- 18. UC Davis Law School will, in a timely manner, provide to the Korea University Law School a transcript for each UCD law student with grades for each course taken at UC Davis Law School.

### Part Four - Exchange of Academic Staff

19. The two law schools may nominate members of their respective academic staff to participate in an exchange for the purpose of study or lecturing in the respective taw schools. The participant is subject to approval by the host law school. The period of exchange will be decided jointly by the two law schools. The host law

school will provide library and research facilities, and other assistance as far as is practicable. The host law school will assist the visiting academic staff in locating accommodation.

In addition to the above, each law school may invite a faculty member of the other law school for the purpose of lecturing or consultation for a short, specified period of time, subject to the approval of the home law school. In such cases the inviting law school will make appropriate funding arrangements agreed to in advance.

- 20. Korea University School of Law and the UC Davis School of Law may create joint programs, conferences and other activities through the mutual agreements of the parties on a case by case basis. Part Four: Amendment, Renewal, Termination, and Approval
- 21. This Exchange Agreement will become effective on the date of signature. It may be terminated by either party provided that written notice of intent to terminate is given at least six months prior to termination. Commitments already in progress shall be fulfilled.
- 22. The Exchange Agreement may be amended by written agreement signed by both law schools.
- 23. The Exchange Agreement will be renewed every five years without change on that date unless one party gives notice six months in advance.
- 24. The Exchange Agreement is subject to ratification by the respective law schools. The Deans of each Law School will be responsible for the execution of this Exchange Agreement.
